CONSENT AGENDA ITEM 5

APPROVED

MOTION BY COUNCIL MEMBER MYERS AND SECOND BY COUNCIL MEMBER HERMANN TO APPROVE THE MINUTES AS WRITTEN. MOTION APPROVED 5-0.

PUBLIC HEARING AND ACTION ITEMS

- 6. Hold public hearing, consider and act regarding Resolution 2022-02 requesting the Argyle Crime Control and Prevention District Board of Directors to order a referendum on the continuation of the Argyle Crime Control and Prevention District for fifteen (15) years and the current one-fourth of one percent local sales and use tax be continued for fifteen (15) years.

Staff summarized the item. Police Chief Jackson reported that the CCPD funds are relied on for Police Department programs and other expenses. The CCPD is scheduled to meet this Thursday to consider ordering the reauthorization election.

Mayor Livingston opened the public hearing at 6:29 p.m. and asked if there was anyone to speak for or against the proposed resolution. There was no one to speak and Mayor Livingston closed the public hearing at 6:30 p.m.

APPROVED

MOTION BY COUNCIL MEMBER BRADFORD AND SECOND BY COUNCIL MEMBER MYERS TO APPROVE RESOLUTION 2022-02 REQUESTING THE ARGYLE CRIME CONTROL AND PREVENTION DISTRICT BOARD OF DIRECTORS TO ORDER A REFERENDUM ON THE CONTINUATION OF THE ARGYLE CRIME CONTROL AND PREVENTION DISTRICT FOR FIFTEEN (15) YEARS AND THE CURRENT ONE-FOURTH OF ONE PERCENT LOCAL SALES AND USE TAX BE CONTINUED FOR FIFTEEN (15) YEARS. MOTION APPROVED 5-0.

- 7. Consider and act regarding Ordinance 2022-02 Calling a General Election and establishing the procedure for the General Election for Three Positions--one at large Alderman for Place One, one at large Alderman for Place Three and one at large Alderman for Place Five to be held on May 7, 2022 in the Town of Argyle, approving the Joint Election Agreement and Contract for Election Services with Denton County and providing other matters relating to the Election.

MOTION BY COUNCIL MEMBER HERMANN AND SECOND BY MAYOR PRO TEM SCHMIDT TO APPROVE ORDINANCE 2022-02 CALLING A GENERAL ELECTION AND ESTABLISHING THE PROCEDURE FOR THE GENERAL ELECTION FOR THREE POSITIONS--ONE AT LARGE ALDERMAN FOR PLACE ONE, ONE AT LARGE ALDERMAN FOR PLACE THREE AND ONE AT LARGE ALDERMAN FOR PLACE FIVE TO BE HELD ON MAY 7, 2022 IN THE TOWN OF ARGYLE, APPROVING THE JOINT ELECTION AGREEMENT AND CONTRACT FOR ELECTION SERVICES WITH DENTON COUNTY AND PROVIDING OTHER MATTERS RELATING TO THE ELECTION. MOTION BY COUNCIL MEMBER MYERS AND SECOND BY COUNCIL MEMBER HERMANN TO APPROVE ORDINANCE 2022-03 ORDERING A SPECIAL ELECTION TO BE HELD ON MAY 7, 2022 IN THE TOWN OF ARGYLE FOR THE PURPOSE OF REAUTHORIZING A ONE-HALF OF ONE PERCENT SALES AND USE TAX FOR THE MAINTENANCE AND REPAIR OF MUNICIPAL STREETS WITHIN THE TOWN OF ARGYLE. MOTION APPROVED 5-0.

MOTION BY COUNCIL MEMBER HERMANN AND SECOND BY COUNCIL MEMBER BRADFORD TO APPROVE ORDINANCE 2022-01 AMENDMENT (TDS-21-009) TO ARTICLE III, ZONING, OF THE TOWN OF ARGYLE TOWN DEVELOPMENT STANDARDS REGARDING VARIOUS AMENDMENTS TO SETBACKS AND BUFFERYARDS FOR COMMERCIAL ZONED DISTRICTS ADJACENT TO RESIDENTIALLY ZONED DISTRICTS IN THE TOWN DEVELOPMENT STANDARDS. MOTION APPROVED 5-0.

10. Consider and take appropriate action on an Amended Site Plan (SP-22-003) for The Well Community Church, an approximately 20,500 sq. ft. church facility, located north of FM 407 and west of US 377, being 12.957 acres and legally described as Lot 8, Block A located in the Patrick Rock Survey, Abstract No. 1063, Town of Argyle, Denton County, Texas.

ACTION ITEM 10

APPROVED

MOTION BY COUNCIL MEMBER BRADFORD AND SECOND BY COUNCIL MEMBER MYERS TO APPROVE AN AMENDED SITE PLAN (SP-22-003) FOR THE WELL COMMUNITY CHURCH, AN APPROXIMATELY 20,500 SQ. FT. CHURCH FACILITY, LOCATED NORTH OF FM 407 AND WEST OF US 377, BEING 12.957 ACRES AND LEGALLY DESCRIBED AS LOT 8, BLOCK A LOCATED IN THE PATRICK ROCK SURVEY, ABSTRACT NO. 1063, TOWN OF ARGYLE, DENTON COUNTY, TEXAS. MOTION APPROVED 5-0.

11. Consider and take appropriate action for a special exception to the Town Development Standards, Section 14.4.14 - Wall Signs, for St Argyle Cajun Kitchen, located at 421 US HWY 377, Town of Argyle, Denton County, Texas.

The applicant, Mr. Tim Hays, Mello Signs, on behalf of the property owner, was present in support of the request and to answer questions. Mr. Steve Watkins, development partner with the restaurants located at US Hwy. 377 and FM 407, addressed Council regarding the request and the challenges of placing signage on the property in compliance with the Town's

sign regulations and TxDOT regulations. Council discussed signage options that would enhance advertising for businesses located in the same immediate area as St Argyle's. Staff will provide follow-up information regarding possible options for monument, way-finding and kiosk signage.

WALL SIGN ON THE WEST FACING WALL OF THE BUILDING FOR ST ARGYLE CAJUN KITCHEN, LOCATED AT 421 US HWY 377, TOWN OF ARGYLE, DENTON COUNTY, TEXAS. MOTION APPROVED 5-0.

MOTION BY COUNCIL MEMBER HERMANN AND SECOND BY COUNCIL MEMBER MYERS TO APPROVE TASK ORDER #4 WITH FREESE AND NICHOLS TO EVALUATE OPTIONS FOR THE CRAWFORD ROAD SEWER LINE. MOTION APPROVED 3 AYES AND 2 NAYS BY MAYOR PRO TEM SCHMIDT AND COUNCIL MEMBER BRADFORD.
