Workshop for Draft FY '19 Budget for the Argyle Crime Control and Prevention District - A discussion about the FY19 was made with a draft budget presented by Cottle. Cottle also introduced a list of additional enhancements request consisting of:

\$5.5K for an interview room recording system

\$2.1K for officer's ballistic vests

\$450 for patrol tint meters

~\$9K for CID redaction hardware and software
