**A. CALL MEETING TO ORDER**

Mayor Pro Tem Hermann called the special meeting to order at 9:00 a.m.

**B. INVOCATION****C. OPEN FORUM:**

This is an opportunity for the public to address the Town Council on any matter, except public hearings that are included on the agenda. Comments related to public hearings will be heard when the specific hearing begins. Each speaker is limited to five (5) minutes, unless the speaker requires the assistance of a translator, in which case the speaker is limited to ten (10) minutes, in accordance with applicable law. Speakers shall address the governing body with civility that is conducive to appropriate public discussion. Speakers can address only the governing body as a whole and not individual city officials or employees. Per the Texas Open Meetings Act, the Town Council is prohibited from deliberating or taking action on any matter not listed on the agenda. The Council may only: (1) make a statement of fact regarding the item; (2) make a recitation of existing policy regarding the item; or (3) propose the item be placed on a future agenda, in accordance with Council adopted procedures.


**D. BUDGET WORKSHOP:**

1. Discussion on the proposed FY 2020-2021 Annual Budget for the Town of Argyle, Texas.

Budget Coordinator, Jeffery Howell, presented Council the proposed revenues and expenditures for fiscal year 2020-2021. Each department head presented council with a detail description of budgetary expenditures proposed for the upcoming fiscal year. Mr. Howell will continue to work with Staff to construct the budget and determine the appropriate tax rates. Future budget workshops will be scheduled throughout the next few months with the final budget and tax rate expected to be presented to Council at the first meeting in September.


E. ADJOURN
